Allen K. Henrie responded stating some concerns reported to him was people were told one price and when they arrived to check into Mr. Desai's motel they were charged a higher price. Mr. Desai was also told the city does not arrange for, or pay for the motel rooms, the committee over the event takes care of those items, not the city.

MULTI PURPOSE EVENT CENTER - Electrical Allen K. Henrie reported on an electrical program sponsored by Rocky Mountain Power that will pay for 1/3 of the costs to update out dated lighting system. The estimated cost to improve the lighting system at the arena is \$18,000.00. Garfield County has agreed to pay half and our cost would be approximately \$6,000.00.

Triple C manager Tony Beckstead is mainly concerned with the arena and hallway areas. He said the arena is very dark. We were given estimates on all of the city buildings.

Allen K. Henrie reported the city has some funding set up in the budget for capitol improvement projects at the Triple C but most of the funding would have to come out of surplus. He also recommended that the council approve new lighting at the Triple C.

Nick Reynolds moved, seconded by Lori Talbot to approve approximately \$6,000.00 towards new lighting at the Triple C and to discuss the remainder of the lights at city owned buildings at the next city council meeting. The motion passed with all in favor.
