<u>BEER PERMIT</u> - REQUEST FOR A ONE DAY BEER PERMIT FOR THE UPCOMING HORSE RACES.</u> The horseman association asked for a one day beer permit for the upcoming horse races in July.

John Orton moved, seconded by Denny Orton to grant a one day beer permit for the upcoming horse races. The motion passed with all in favor.

Steve Marshall voiced some concerns regarding vehicles crossing the race track. Steve also stated that Brady Eyre may have a solution to help the dirt track from getting so hard and would like to see the city to check into a solution for this problem. John Orton would like the city to purchase a device to place on the track for vehicle traffic. **SECONDARY WATER** Allen K. Henrie reported on a meeting he had with Vermon Barney regarding his field watering with the secondary water shares. The city would like Mr. Barney to hook into West Panguitch irrigation.

Mayor Oldham asked Allen K. Henrie to talk with Mr. Barney again to determine what it would take to connect him to West Panguitch irrigation. Allen will update the city council on his progress next council meeting.

Denny Orton moved, seconded by Randy Hatch to instruct the city manager to visit with Mr. Barney regarding the secondary water and work on connecting him to West Panguitch. The motion passed with all in favor.

ANNEXATION RECOMMENDATIONS Allen K. Henrie reported on the planning and zoning regarding annexation. The recommendation from the Planning and Zoning board was to annex the areas around the city owned by the city and county which would include the baseball complex, fair grounds, industrial park and the public safety facility. The board recommended the city did not pursue the area privately owned north on 89 and south on 143 past the KOA until Attorney Lee can check the legalities of annexing private owned property.

John Orton moved, seconded by Denny Orton to table until the next city council meeting and instruct Allen K. Henrie to obtain descriptions of areas the city would like to annex. The motion passed with all in favor.

LEASES The city council discussed leases for the industrial park businesses. Attorney Wallace Lee prepared industrial park lease agreement for K & D Forest Products, Tom Simkins and Ken & Ren Construction.

Denny Orton moved, seconded by Randy Hatch to approve three separate leases with K & D Forest Products, Tom Simkins and Ken and Ren Construction under the condition that they comply with the Panguitch City Industrial Park lease agreements. The motion passed with all in favor.

BUSINESS LICENSE - DENNY'S HOME REPAIR AND INSPECTION

Randy Hatch moved, seconded by John Orton to table this item until the next city council. The city council must have three votes in order to pass an item. Where Mr. Orton is on the city council he cannot vote. The motion passed with all in favor. **<u>CURRENT BILLS</u>** The council reviewed the current bills to be paid.

The council discussed other upcoming events. Things are going well with the Triple C.

WATER PROJECT JDM finished up the final work that needed to be completed.

PENDING BUSINESS The pending business list was edited.

Dumpsters - The county has hired someone to clean up around the green dumpsters at the river lane road.

4th of **July** - The Senior class over the fourth of July celebration are moving forward well and will be held on Saturday, July 3, 2004.
