Present at the City Council meeting were Mayor Pro-Tem John Orton, City Manager Allen K. Henrie, City Recorder Cindy B. Johnson, City Council Members Eric Houston, Greg Payne, Nick Reynolds, Tim Smith and Attorney Barry Huntington. Mayor J. Arthur Cooper was excused.

<u>MUNICIPAL JUDGE INTERVIEWS</u> There were three applicants to be interviewed for the Justice Court Judge; Stan Foy, Tad Draper, and Martin Nay. Mr. Draper was informed that he was not eligible for the position, because he did not live within the city limits or in Garfield County for three years. He asked to go ahead with the interview anyway for experience purposes. The applicants were asked a set of eight questions.

Tim Smith moved, seconded by Eric Houston to move into executive session at 8:40 p.m. to discuss the personal and professional competence of an individual. The motion passed with all in favor.

Greg Payne moved, seconded by Eric Houston to come out of executive session at 9:08 p.m. The motion passed with all in favor.

Eric Houston moved, seconded by Tim Smith to offer the Justice Court Judge position to Martin Nay. The motion passed with all in favor.

Eric Houston moved, seconded by Tim Smith to accept the General Fund budget, Water budget and Sewer budget as listed above. The motion passed with all in favor.

<u>CHIP SEAL - COST OVER RUN</u> Lamb Construction have stayed with their bid from last year. However, we asked for a bid on square yards rather than on a 24 foot roadway. Lambs chip sealed a 26 foot roadway which brought the cost up by \$35,000.00.

We also did the road into the baseball complex. Allen K. Henrie would like to see if the county would chip seal Pig Weed Lane, Industrial Park and to the Garfield County Public

Safety Facility.

Most of the town is completed, but we still need to do behind the stores which will need a double chip seal. Allen K. Henrie discussed the options on paying for the chip seal over-run costs.

Greg Payne moved, seconded by Eric Houston to continue the completion of the chip seal that is not done. The motion passed with all in favor.

<u>KAIBAB PRELIMINARY SUBDIVISION PLATT</u> Jeff Albrecht was in attendance to present the city council with a preliminary plat plan for the Kaibab subdivision.

Nick Reynolds moved, seconded by Greg Payne to accept the preliminary plat plan from Kaibab. The motion passed with all in favor.

<u>SUBDIVISION METER CHARGE</u> New subdivisions are bringing water and sewer connections to the property lines but do not provide the water meter. When the city puts in a service, the water meter is included.

Allen K. Henrie feels it is justifiable to charge \$75.00 to \$100.00 after consulting with the maintenance crew.

Nick Reynolds moved, seconded by Greg Payne to charge \$100.00 for a new meter and turn on. The motion passed with all in favor.

FIRE DEPARTMENT - DAVE DODDS There was an incident involving the fire department. While en route to a scene, the doors on the engine box came open, equipment fell out and was damaged. The firemen assumed insurance would pay for the equipment but found out there is only liability coverage on that particular fire truck. The two largest trucks are worth \$200,000.00 without any equipment.

PANGUITCH CITY COUNCIL MINUTES JUNE 26, 2007 PAGE 6 Chief Dave Dodds feels the city needs to look into our insurance coverage and see if it is adequate. He informed the council that the turnout gear the firemen wear is worth \$77,000.00 alone.

Allen K. Henrie and Carla Farnsworth will call and see where the city is at and what is covered. Chief Dodds will get some costs together of the contents of both the fire station and the equipment on the trucks, so the city will have an idea of insurance coverage needed.

Tim Smith moved, seconded by Greg Payne to give authority to increase the fire insurance up to \$4,000.00 before it is necessary to come back to the city council for approval. The motion passed with all in favor.
