ADOPTION OF THE AGENDA

Tim Smith feels if you pay a little more you get a much better product and a better warranty. He also said he is in total favor of this proposed skate board park.

Allen K. Henrie stated that he has not seen very many people who have worked as hard as this skate board park committee to get this park here and feels they have done a great job.

Cheryl would like to have some bags made and give one to each household in the community. The bags would have information inside to promote shopping at home. She asked if the city would be willing to pay half on the project which would be approximately \$600.00.

Nick Reynolds moved, seconded by Tim Smith to support Main Street on the shop at home program with funding of up to \$600.00. The motion passed with all in favor.

PUBLIC HEARING - NEW ZONING MAP The public hearing regarding the new zoning map needed to be advertised for two weeks. This did not happen.

Tim Smith moved, seconded by Nick Reynolds to table the Public Hearing until next city council meeting. The motion passed with all in favor.

CITIZEN COMMENT Leland Pollock asked Mayor Cooper to thank all of those involved in the committee that made Highway 143 a National Scenic Byway. Allen K. Henrie stated that Leland has worked hard on the committee and deserves much credit for this happening designation.

MULTI PURPOSE EVENT CENTER The final Little Britches rodeo was held for the 2009 year. Upcoming is the wrestling tournament and the New Years Eve party.
